POLL RESULTS OF ANNUAL GENERAL MEETING HELD ON 6 JUNE 2018

The board of directors (“**Board**”) of K. Wah International Holdings Limited (“**Company**”) announces that each of the resolutions as set out in the notice dated 20 April 2018 (“**Notice**”) convening the Annual General Meeting held on 6 June 2018 (“**AGM**”) was duly passed by way of poll.

The total number of shares of the Company in issue at the date of the AGM was 3,060,249,052 (“**Shares**”), which represented the total number of Shares entitling the holders (“**Shareholders**”) to attend and vote for or against all the resolutions proposed at the AGM. There were no restrictions on any Shareholders casting votes on any of the proposed resolutions at the AGM.
