### **POLL RESULTS OF ANNUAL GENERAL MEETING**

At the annual general meeting of Lung Kee (Bermuda) Holdings Limited (the “Company”) held on 15th May, 2017 (the “AGM”), all the resolutions were passed by the shareholders of the Company by poll voting.

The Board of Directors of the Company is pleased to announce that at the AGM of the Company held on 15th May, 2017, all the resolutions were duly passed by the shareholders of the Company. At the AGM, a poll was demanded by the Chairman for voting on all proposed resolutions as set out in the Notice of the AGM dated 3rd April, 2017 (the “AGM Notice”).

The existing issued share capital of the Company is 631,677,303 shares, with the total number of shares entitling the holders to attend and vote on a resolution at the AGM was 631,677,303 shares. There was no share entitling the holder to attend and abstain from voting in favour at the AGM as set out in rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”).

No shareholder of the Company was required under the Listing Rules to abstain from voting on the resolutions at the AGM. None of the shareholders has stated their intention in the Company’s circular dated 3rd April, 2017 (the “Circular”) to vote against any resolution or to abstain from voting at the AGM.

The Company’s Hong Kong branch share registrar and transfer office, Computershare Hong Kong Investor Services Limited acted as scrutineer for the vote-taking at the AGM.
