On 17 March 2014, Firmwill Investment Limited (“the Purchaser”), Ying Hui Limited (“the Vender”) and the Vender’s shareholders entered into the Supplemental Agreement pursuant to which parties agreed to (i) extend the Long Stop Date; (ii) revise the consideration for the Acquisition with reference to the Unaudited 2013 Profit and the relevant settlement arrangements; (iii) cancel the Profit Guarantee; and (iv) amend the conditions precedent to the UDL SPA to reflect the changes relating to the New consideration and the cancellation of the Profit Guarantee.
