POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON FRIDAY, 19 MAY 2017

At the annual general meeting of Shanghai Industrial Urban Development Group Limited (the “**Company**”) held on Friday, 19 May 2017 (the “**AGM**”), all the proposed resolutions as set out in the notice of the AGM (the “**AGM Notice**”) of the Company were taken by way of poll.

POLL RESULTS OF THE AGM

Reference is made to the AGM Notice and the circular of the Company (the “**AGM Circular**”) both dated 13 April 2017. Unless the context otherwise requires, capitalised terms used herein shall have the same meanings as those defined in the AGM Notice and the AGM Circular.

The Board is pleased to announce that all the resolutions as set out in the AGM Notice contained in the AGM Circular and proposed at the AGM were duly passed by way of poll at the AGM. Tricor Secretaries Limited, the Company’s branch share registrar and transfer office in Hong Kong, was appointed as the scrutineer for the vote-taking at the AGM.

As more than 50% of the votes were cast in favour of each of the resolutions numbered 1 to 7 above, the resolutions numbered 1 to 7 above were duly passed as ordinary resolutions of the Company and as more than 75% of the votes were cast in favour of the resolution numbered 8 above, the resolution numbered 8 above was duly passed as a special resolution of the Company.

As at the date of the AGM, the total number of issued Shares was 4,811,273,189, representing the total number of Shares entitling the holders to attend and vote for or against all the resolutions proposed at the AGM. No Shareholder was entitled to attend and abstain from voting in favour of the resolutions proposed at the AGM. No Shareholder was required under the Listing Rules to abstain from voting on the resolutions at the AGM and no Shareholder has stated his/her intention in the AGM Circular to vote against any of the resolutions or to abstain from voting at the AGM.
