**VOLUNTARY ANNOUNCEMENT  
FURTHER INCREASE IN SHAREHOLDING IN THE  
COMPANY BY A DIRECTOR**

This announcement is made by China Nuclear Energy Technology Corporation Limited (the “**Company**”), together with its subsidiaries, the “**Group**”) on a voluntary basis.

The board of directors (the “**Board**”) of the Company was informed by Mr. Liu Genyu (“**Mr. Liu**”), an executive director and the vice president of the Company, that Mr. Liu further acquired an aggregate of 2,216,000 ordinary shares of the Company (“**Shares**”) in the open market on 26 April 2022 at an average price of approximately HK\$0.861 per Share, representing approximately 0.16% of issued Shares of the Company. Immediately after the purchase, Mr. Liu is interested in an aggregate of 29,016,000 Shares, representing approximately 2.21% of the total issued share capital of the Company as at the date of this announcement.

As advised by Mr. Liu, he has unswerving confidence in the future prospects and development of the Group in photovoltaic power, wind power and other renewable energy industry. In compliance with applicable laws and regulatory requirements, Mr. Liu does not rule out that he will continue to increase his shareholding in the Company as when appropriate.
