PROPOSED PAYMENT OF FINAL DIVIDEND AND CLOSURE OF REGISTER OF MEMBERS

Reference is made to the announcement (the “**Announcement**”) of Infinity Chemical Holdings Company Limited (the “**Company**”) dated 30 December 2013 relating to the annual results of the Company and its subsidiaries for the year ended 30 September 2013. As stated in the Announcement, the board (the “**Board**”) of directors (the “**Directors**”) of the Company recommends the payment of a final dividend of HK1.6 cents per share (the “**Final Dividend**”) for the year ended 30 September 2013 to shareholders of the Company (the “**Shareholders**”) whose names appear on the register of members (the “**Register**”) of the Company at 4:30 p.m. on Wednesday, 5 March 2014 (the “**Record Date**”). The Final Dividend is subject to approval by the Shareholders at the annual general meeting of the Company to be held on Wednesday, 26 February 2014 (the “**AGM**”) and a resolution will be proposed to the Shareholders for voting at the AGM.

CLOSURE OF REGISTER OF MEMBERS

The Register will be closed from Thursday, 6 March 2014 to Friday, 7 March 2014 (both dates inclusive) in order to determine the Shareholders’ entitlements to the Final Dividend, during which no transfer of shares of the Company will be registered.

To qualify for the Final Dividend, all transfer of shares accompanied by the relevant share certificates must be lodged with the Company’s branch share registrar and transfer office in Hong Kong, Tricor Investor Services Limited (the “**Share Registrar**”) at 26th Floor, Tesbury Centre, 28 Queen’s Road East, Wan Chai, Hong Kong for registration no later than 4:30 p.m. on Wednesday, 5 March 2014.

Shareholders whose names appear on the Register on the Record Date, i.e. 4:30 p.m. on Wednesday, 5 March 2014 will be entitled to the Final Dividend.
