**VOLUNTARY ANNOUNCEMENT**

**INCREASE IN SHAREHOLDING OF A CONTROLLING SHAREHOLDER**

This is a voluntary announcement made by Tianyi (Summi) Holdings Limited (the “**Company**”) to update its shareholders and potential investors in relation to the increase in shareholdings of Mr. Sin Ke (“**Mr. Sin**”), being the chairman of the board of directors, the chief executive officer and a controlling shareholder of the Company.

The Company was informed by Mr. Sin that on 29 September 2016, he, through Key Wise Group Limited (being a controlling shareholder of the Company and owned as to 49% by Mr. Sin and 51% by his spouse, Ms. Hong Man Na), purchased 2,500,000 ordinary shares (the “**Share**”) of the Company at the total consideration of HK\$2,652,440 with an average price of approximately HK\$1.061 per Share. The said 2,500,000 Shares represent approximately 0.186% of the entire issued share capital of the Company as at the date of this announcement.
