Appointment of Executive Director, Chairman and Chief Executive Officer as well as Nomination Committee Member

The board of directors (the “Board”) of China Unicom (Hong Kong) Limited (the “Company”) announces that Mr. Liu Liehong, has been appointed as an Executive Director, Chairman and Chief Executive Officer as well as Nomination Committee Member of the Company with effect from 3 September 2021.

Mr. Liu Liehong, aged 52, a postgraduate with a doctorate degree in Management. Mr. Liu served as Head of the Electronics Second Research Institute under the Ministry of Information Industry, Deputy General Manager of China Electronics Technology Group Corporation, President of China Electronics and Information Industry Development Research Institute and President of CCID Information Industry Group Corporation, Director and General Manager of China Electronics Corporation, Director and General Manager of China Electronics Technology Group Corporation, Vice Minister of the Office of the Central Cyberspace Affairs Commission, Vice Minister of the Cyberspace Administration of China, Vice Minister of the Ministry of Industry and Information Technology, and a Member of the 12th National Committee of the Chinese People's Political Consultative Conference. Mr. Liu is currently the Chairman of China United Network Communications Group Company Limited and China United Network Communications Corporation Limited. Mr. Liu has extensive experience in management and information industry. Mr. Liu has been appointed as an Executive Director, Chairman and Chief Executive Officer as well as Nomination Committee Member of the Company with effect from the date of this announcement.

Mr. Liu Liehong has not entered into any service contract with the Company, which provides for a specified length of service. The terms of services do not expressly require the Company to give more than one year’s notice period or to make payments equivalent to more than one year’s emoluments to terminate the service. Pursuant to the articles of association, Mr. Liu Liehong is required to retire from office of director and shall be eligible for re-election at the next following annual general meeting of the Company.
