**QUARTERLY UPDATE – OPERATING INFORMATION FOR
THE SIX MONTHS ENDED 30 JUNE 2016**

The Group recorded a new contract value of HK\$1,852 million in the six months ended 30 June 2016, representing a growth of 21.3% as compared with the same period last year, and hence achieved a 61.7% completion of the full year target of 2016 (which is not less than HK\$3,000 million).

As of 30 June 2016, the on-hand contract value amounted to approximately HK\$8,066 million, among which the backlog was approximately HK\$4,298 million (representing an increase of 20.8% as compared to the backlog as of 30 June 2015), which meets the Group's expected future works.
