CHANGE OF COMPANY NAME AND STOCK SHORT NAMES

The Board is pleased to announce that the English and Chinese name of the Company has been changed from “Fornton Group Limited 豐臨集團有限公司” to “Infinity Financial Group (Holdings) Limited 新融宇集團(控股)有限公司”.

Following the passing of the special resolution approving the Change of Company Name at the SGM held on 23 September 2014, a Certificate of Incorporation on Change of Name was issued by the Registrar of Companies in Bermuda on 1 October 2014 and a Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 16 October 2014.

With effect from 9:00 a.m. on 24 October 2014, the stock short names of Shares for trading on the Stock Exchange will be changed from “FORNTON GROUP” to “INFINITY FIN” in English and from “豐臨集團” to “新融宇集團” in Chinese. The stock code of the Company will remain unchanged as “1152”.

ADOPTION OF NEW COMPANY LOGO

Infinity Financial Group (Holdings) Limited as the new logo with immediate effect.

CHANGE OF COMPANY WEBSITE

References are made to the announcement of Infinity Financial Group (Holdings) Limited (formerly known as Fornton Group Limited) (the “**Company**”) dated 22 August 2014 and the circular of the Company dated 27 August 2014 (the “**Circular**”) in relation to the proposed Change of Company Name. Capitalised terms used in this announcement have the same meaning as those defined in the Circular unless otherwise stated herein.

CHANGE OF COMPANY NAME

EFFECT ON CHANGE OF COMPANY NAME

The Change of Company Name will not affect any rights of the holders of securities of the Company or the Company’s daily business operation and its financial position. The existing certificates of securities in issue bearing the former name of the Company will continue to be good evidence of title to such securities and be valid for trading, settlement, registration and delivery purposes. Accordingly, there will not be any arrangement for free exchange of the existing certificates of securities of the Company for new certificates bearing the new English name and Chinese secondary name of the Company. As the Change of Company Name has become effective, new certificates of securities of the Company will be issued only in the new English name and Chinese secondary name of the Company in any subsequent issue of Shares.
