PROFIT ALERT ANNOUNCEMENT – ESTIMATED DECREASE IN LOSS FOR THE YEAR ENDED 31 DECEMBER 2025

This announcement is made by Renze Harvest International Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong)(the “**SFO**”).

The board (the “**Board**”) of directors (the “**Director(s)**”) of the Company wishes to inform the shareholders and potential investors of the Company that based on the preliminary review of the unaudited consolidated management accounts of the Group for the year ended 31 December 2025 (the “**FY2025**”) and information currently available, the Group expects to record a loss for the year of not more than HK\$130,000,000 as compared to a loss for the year of approximately HK\$319,590,000 for the year ended 31 December 2024 (“**FY2024**”).

The estimated decrease in loss for the Year was primarily attributable to:

- (i) decrease of fair value loss on investment properties from approximately HK\$280,741,000 in FY2024 to approximately HK\$67,308,000 during FY2025; and
- (ii) significant reduction of write-down of inventories of properties to approximately HK\$873,000 for FY2025, as compared to HK\$151,329,000 in FY2024.

As of the date of this announcement, the Company is still in the process of finalising its annual results of FY2025. The information contained in this announcement is only based on a preliminary estimation performed by the management of the Company based on the currently available information which is still subject to possible adjustment following further internal review by the Board. Details of the financial performance of the Company will be announced by the Company as and when required by the Listing Rules and the SFO.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the shares of the Company.
