CHANGE OF COMPANY NAME AND CHANGE OF STOCK SHORT NAME

References are made to the announcement of Renze Harvest International Limited (formerly known as Glory Sun Financial Group Limited) (the “**Company**”) dated 21 April 2023, the circular of the Company dated 10 May 2023 (the “**Circular**”) and the announcement of the Company dated 28 June 2023 in relation to the poll results of the AGM. Unless otherwise stated, capitalised terms used herein shall bear the same meanings as those defined in the Circular.

CHANGE OF COMPANY NAME

The Board is pleased to announce that the English name of the Company has been changed from “Glory Sun Financial Group Limited” to “Renze Harvest International Limited” and the dual foreign name of the Company has been changed from “寶新金融集團有限公司” to “中澤豐國際有限公司”.

The Certificate of Incorporation on Change of Name of the Company was issued by the Registrar of Companies in the Cayman Islands on 11 July 2023 and the Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Hong Kong Companies Registry on 31 July 2023.

CHANGE OF STOCK SHORT NAME

The stock short name of the Shares for trading on the Stock Exchange will be changed from “GLORY SUN FIN” to “RENZE HARVEST” in English and from “寶新金融” to “中澤豐” in Chinese with effect from 9:00 a.m. on 7 August 2023. The stock code of the Company remains unchanged as “01282”.

EFFECTS OF THE CHANGE OF COMPANY NAME

The Change of Company Name will not affect any rights of the Shareholders and the website of the Company remains unchanged as “www.hk1282.com”.

All existing share certificates in issue bearing the former name of the Company shall continue to be evidence of title to such shares and the existing share certificates shall continue to be valid for trading, settlement, registration and delivery purposes. Accordingly, there will not be any arrangement for free exchange of the existing share certificates for new certificates bearing the new English and dual foreign names of the Company. New share certificates will be issued under the new English and dual foreign names with effect from 31 July 2023.
