POLL RESULTS OF ANNUAL GENERAL MEETING HELD ON 30 JUNE 2021

At the annual general meeting (the “AGM”) of China Carbon Neutral Development Group Limited (the “**Company**”) held on 30 June 2021, a poll was demanded by the chairman of the AGM for voting on all the proposed resolutions as set out in the notice of AGM dated 31 May 2021 (the “**AGM Notice**”).

As at the date of the AGM, the total number of issued shares of the Company was 260,000,000 of HK\$0.01 each, which was the total number of shares entitling the holders to attend and vote for or against the resolutions at the AGM. There were no shares entitling the holders to attend and abstain from voting in favour of the resolutions at the AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”). No shareholder of the Company was required under the Listing Rules to abstain from voting on the resolutions at the AGM.

None of the shareholders of the Company have stated their intention in the Company’s circular dated 31 May 2021 (the “**Circular**”) to vote against or to abstain from voting on any of the resolutions at the AGM.

The branch share registrar and transfer office of the Company in Hong Kong, Tricor Investor Services Limited, was appointed as the scrutineer of the vote-taking at the AGM.

As more than 50% of the votes were cast in favour of all the resolutions proposed at the AGM, all such resolutions were duly passed as ordinary resolutions by way of poll at the AGM.
