Signing of Strategic Co-operation Framework Agreement with the Zhengzhou University of Technology

This is a voluntary announcement made by China Carbon Neutral Development Group Limited (the "Company", together with its subsidiaries, the "Group") to inform the shareholders of the Company and potential investors of the latest news on the Group's business development.

The board of directors of the Company (the "**Board**") is pleased to announce the signing of a strategic co-operation framework agreement between the Group and Zhengzhou University of Technology to accelerate the green and low-carbon transformation and effectively carry out carbon peaking and carbon neutrality initiatives. By leveraging each other's strengths and upholding the principle of "mutual development and sincere cooperation", the following cooperation initiatives will be undertaken:

providing research guidance and staff training during and after the operation period of the R&D Centre.

The Zhengzhou University of Technology is located in Zhengzhou City, Henan Province, China. It is a provincially administered public full-time undergraduate university in Henan Province, and it is a national pilot university for training skill-type and scarce talents in the construction industry in China. Founded in 1980 as a branch of Zhengzhou University and Henan Medical College, the Zhengzhou University of Technology currently offers a total of 34 undergraduate majors and 31 junior college majors, covering six disciplines including engineering, economics, management, arts, literature, and education.

The Board is of the view that the strategic framework agreement signed between the Group and the Zhengzhou University of Technology is not only of positive significance for promoting the realization of the country's green transformation but also contributes to promoting ecological construction and facilitating harmonious development between humans and nature. The Company believes that this cooperation will bring sustainable business growth and financial returns to the Group and lay a solid foundation for expanding other businesses, and further consolidate the overall interests of the Group and the shareholders of the Company.
