**FACILITY AGREEMENT WITH SPECIFIC PERFORMANCE COVENANTS**

This announcement is made by Canvest Environmental Protection Group Company Limited (the “**Company**”) pursuant to Rule 13.18 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”).

**AGREEMENT**

The board of directors (the “**Board**”) is pleased to announce that on 5 August 2021, the Company (as borrower) entered into a facility agreement (the “**Agreement**”) with a financial institution (as lender) pursuant to which a term loan facility in the aggregate amount of HK\$150,000,000 for a term of 36 months from the date of drawdown was granted to the Company.

**DISCLOSURE UNDER RULE 13.18 OF THE LISTING RULES**

Pursuant to the Agreement, it shall constitute a mandatory prepayment event (among others) if (i) Ms. LEE Wing Yee Loretta, Mr. LAI Kin Man and Mr. LAI Chun Tung and any trust established by any of them (collectively, the “**Controlling Shareholders**”) collectively cease (directly or indirectly) to own more than 35% or above of the total shares of the Company; or (ii) the Controlling Shareholders cease to be collectively the single largest shareholder of the Company or lose management control in the Company.

Such specific performance obligation imposed on the Controlling Shareholders under the Agreement is required to be disclosed by the Company pursuant to Rule 13.18 of the Listing Rules. As at the date of this announcement, the Controlling Shareholders beneficially holds approximately 55.2% of the total issued share capital of the Company.

The Company shall make continuing disclosure in its subsequent annual and interim reports for so long as the above specific performance obligations continue to exist pursuant to Rule 13.21 of the Listing Rules.
