Facility Agreement

On 30 November 2018, the Company (as borrower) and two of its Hong Kong incorporated subsidiaries (as guarantors) entered into a facility agreement (the "Facility Agreement") with (among other parties) six financial institutions (as lenders) (collectively, the "Lenders") for a syndicated term loan facility for an aggregate amount of US\$150 million.

The final repayment date of the loan facility shall be the date falling 36 months after the first utilization date. The purpose of the loan facility is primarily to improve the structure of indebtedness and for the corporate funding requirements of the Company and its subsidiaries. Upon completion, the Group further optimzes its debt structure and effectively reduce its finance costs.

Specific Performance Obligation

Under the Facility Agreement, if Mr. Wang Muqing (王木清先生, "Mr. Wang", the Company's controlling shareholder), his close relatives or any trust of which Mr. Wang and his close relatives are beneficiaries ceasing to own beneficially (whether directly or indirectly) no less than 50% of the total issued share capital of the Company, the majority Lenders may require to cancel the total commitments under the Facility Agreement, and all the outstanding amount under the Facility Agreement together with interest accrued thereon may become immediately due and payable.

As at the date of this announcement, Mr. Wang and/or his family members are the discretionary beneficiaries of the Bright Brilliant Trust, which Trust indirectly owns approximately 56.37% of the issued share capital of the Company.
