**POLL RESULT OF EXTRAORDINARY GENERAL MEETING  
HELD ON 28 DECEMBER 2023**

The board (the “**Board**”) of directors (the “**Directors**”) of China ZhengTong Auto Services Holdings Limited (the “**Company**”) announce that at the extraordinary general meeting of the Company held on 28 December 2023 (the “**EGM**”), the proposed resolutions set out in the notice of the EGM dated 5 December 2023 (the “**EGM Notice**”) were not passed by the shareholders of the Company by way of poll.

As at the date of the EGM, the total number of issued and fully paid up shares of the Company (the “**Shares**”) was 2,867,102,420 Shares, which was the total number of Shares entitling the holders to attend and vote for or against the resolutions at the EGM. There were no Shares entitling the holders to attend and abstain from voting in favour of the resolutions at the EGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and no holder of Shares was required under the Listing Rules to abstain from voting at the EGM. No parties had stated their intention in the Company’s circular dated 5 December 2023 to vote against or to abstain from voting on the resolution proposed at the EGM. All Directors attended the EGM.
