### **UNAUDITED OPERATING STATISTICS FOR JUNE 2015**

The board of directors (the “Board”) of KWG Property Holding Limited (the “Company”) is pleased to announce certain unaudited operating statistics of the Company and its subsidiaries (the “Group”) for June 2015 as follows.

In June 2015, the Group’s gross pre-sales value amounted to RMB2,423 million. The Group’s attributable pre-sales value amounted to RMB1,985 million (as compared to RMB1,778 million in May 2015 and RMB1,779 million in June 2014), representing a month-on-month increase of 11.6% and a year-on-year increase of 11.6%, respectively. The Group’s attributable pre-sales area amounted to approximately 141,000 sq. m. (as compared to 142,000 sq. m. in May 2015 and 138,000 sq. m. in June 2014).

For the first six months of 2015, the Group has achieved a total of RMB9.4 billion of attributable pre-sales value, representing 42% of the Group’s full year pre-sales target of RMB22.5 billion.

The above-mentioned sales data is unaudited and is based on preliminary internal information of the Group, which may differ from figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or half-yearly basis due to various uncertainties during the process of collating such sales information. As such, the above data is provided for investors’ reference only.
