UNAUDITED OPERATING STATISTICS FOR NOVEMBER 2015

The board of directors (the “**Board**”) of KWG Property Holding Limited (the “**Company**”) is pleased to announce certain unaudited operating statistics of the Company and its subsidiaries (the “**Group**”) for November 2015 as follows.

In November 2015, the Group’s gross pre-sales value amounted to RMB2,062 million. The Group’s attributable pre-sales value amounted to RMB1,968 million (as compared to RMB1,942 million in October 2015 and RMB1,851 million in November 2014), representing a month-on-month increase of 1.3% and a year-on-year increase of 6.3%, respectively. The Group’s attributable pre-sales area amounted to approximately 142,500 sq. m. (as compared to 149,200 sq. m. in October 2015 and 138,000 sq. m. in November 2014).

For the first eleven months of 2015, the Group has achieved a total of RMB17.8 billion of attributable pre-sales value, representing 79% of the Group’s full year pre-sales target of RMB22.5 billion.

The above-mentioned sales data is unaudited and is based on preliminary internal information of the Group, which may differ from figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or half-yearly basis due to various uncertainties during the process of collating such sales information. As such, the above data is provided for investors’ reference only.
