### **UNAUDITED OPERATING STATISTICS FOR OCTOBER 2016**

The board of directors (the “**Board**”) of KWG Property Holding Limited (the “**Company**”) is pleased to announce certain unaudited operating statistics of the Company and its subsidiaries (the “**Group**”) for October 2016 as follows.

In October 2016, the Group’s gross pre-sales value amounted to RMB2,261 million. The Group’s attributable pre-sales value amounted to RMB1,775 million (as compared to RMB2,426 million in September 2016 and RMB1,942 million in October 2015), representing a month-on-month decrease of 26.8% and a year-on-year decrease of 8.6%, respectively. The Group’s attributable pre-sales area amounted to approximately 128,000 sq. m. (as compared to 215,000 sq. m. in September 2016 and 149,200 sq. m. in October 2015).

For the first ten months of 2016, the Group has achieved a total of approximately RMB19.3 billion of attributable pre-sales value, representing 88% of the Group’s full year pre-sales target of RMB22.0 billion.

The above-mentioned sales data is unaudited and is based on preliminary internal information of the Group, which may differ from figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or half-yearly basis due to various uncertainties during the process of collating such sales information. As such, the above data is provided for investors’ reference only.
