FOR FEBRUARY 2018

The board of directors (the “Board” and the “Directors” respectively) of KWG Property Holding Limited (the “Company”) is pleased to announce certain unaudited operating statistics of the Company and its subsidiaries (the “Group”) for February 2018 as follows.

For February 2018, the Group’s pre-sales value amounted to RMB4,128 million, representing a year-on-year increase of 128.1%. The Group’s pre-sales area amounted to approximately 243,000 square meters, representing a year-on-year increase of 86.9%.

The above-mentioned sales data is unaudited and is based on preliminary internal information of the Group, which may differ from figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or half-yearly basis due to various uncertainties during the process of collating such sales information.
