### PROFIT WARNING

This announcement is made by Ten Pao Group Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571, Laws of Hong Kong).

The board of directors (the “**Board**”) of the Company wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that, based on the preliminary review by the Board on the unaudited management accounts of the Group for the four months ended 30 April 2018, which have not been reviewed or audited by the independent auditors and/or the audit committee, and taking into consideration the sales and shipping plan of the Group for May and June 2018 and the information currently available to the Board, it is expected to record a loss attributable to equity holders of the Company for the six months ending 30 June 2018. The expected loss is mainly due to the increase of raw material cost and salary putting gross profit under pressure, and the negative impact of RMB appreciation on the export business during the period.

As the Company has not yet prepared the consolidated financial results of the Group for the six months ending 30 June 2018, the information contained in this announcement is only based on the information currently available to the Company and the preliminary review by the Board on the unaudited management accounts of the Group for the four months ended 30 April 2018, which have not been reviewed or audited by the independent auditors and/or the audit committee of the Company. The actual financial results of the Group for the six months ending 30 June 2018 may differ from what is disclosed in this announcement. Shareholders and potential investors are advised to read carefully about the announcement of the Company for the interim results for the six months ending 30 June 2018, which is expected to be published in August 2018 in accordance with the requirements of the Listing Rules.
