POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 23 APRIL 2020

All the Resolutions set out in the AGM Notice were duly passed by the Shareholders as ordinary resolutions by way of poll at the AGM.

Reference is made to the circular dated 23 March 2020 (the “**Circular**”) of Tsit Wing International Holdings Limited (the “**Company**”). Unless the context requires otherwise, terms used herein shall have the same meanings as those defined in the Circular.

The Board is pleased to announce that all the Resolutions set out in the notice of the AGM dated 23 March 2020 (the “**AGM Notice**”) were duly passed by the Shareholders by way of poll at the AGM.

As at the date of the AGM, there were 748,141,712 issued Shares entitling the Shareholders to attend and vote on the Resolutions at the AGM. No Shareholder was entitled to attend but abstain from voting in favour of the Resolutions at the AGM as set out in Rule 13.40 of the Listing Rules.

None of the Shareholders were required under the Listing Rules to abstain from voting on any of the Resolutions at the AGM. None of the Shareholders have stated in the Circular their intention to vote against or to abstain from voting on any of the Resolutions at the AGM.
