Introduction

The purpose of this circular is to provide you with information regarding, inter alia:

- (a) grant of the Share Issue Mandate (as defined below) to issue shares of the Company (the “Shares”);

- (b) grant of the Share Repurchase Mandate (as defined below) for repurchase by the Company of the Shares;
- (c) grant of a general extension mandate to extend the Share Issue Mandate to include Shares repurchased under the Share Repurchase Mandate, if any; and
- (d) re-election of the directors of the Company (the “**Directors**”).

1. General mandate to issue Shares and extension of general mandate

At the last annual general meeting of the Company held on 23 June 2006, a general mandate was granted to the Directors to allot, issue and deal with the Shares. Such mandate will lapse at the conclusion of the Annual General Meeting. Two ordinary resolutions will accordingly be proposed at the Annual General Meeting for the shareholders to consider and, if thought fit, grant respectively, a general mandate to the Directors to exercise the power of the Company to allot, issue and deal with the Shares (the “**Share Issue Mandate**”) not exceeding 20% of the issued share capital of the Company on the date of passing the resolution approving the Share Issue Mandate, and an extension of the Share Issue Mandate by adding any Shares representing the nominal amount of the Shares repurchased by the Company after the granting of the general mandate to repurchase up to 10% of the issued share capital of the Company at the date of the Share Repurchase Mandate (as defined below).

Details of the Share Issue Mandate are respectively set out in Resolutions 6 and 7 in the Notice of the Annual General Meeting set out on pages 12 to 15 of this circular. The Share Issue Mandate will expire upon whichever is the earliest of: (a) the conclusion of the next annual general meeting of the Company; (b) the expiration of the period within which the next annual general meeting of the Company is required to be convened by the articles of the association of the Company or by any applicable law(s); and (c) the date on which the authority given under the ordinary resolution approving the Share Issue Mandate is revoked or varied by an ordinary resolution of the shareholders.

2. General mandate to repurchase Shares

At the last annual general meeting of the Company held on 23 June 2006, a general mandate was granted to the Directors to exercise the powers of the Company to repurchase the Shares. Such mandate will lapse at the conclusion of the Annual General Meeting. An ordinary resolution will hence be proposed for the shareholders to consider and, if thought fit, grant a general mandate to the Directors to exercise the power of the Company to repurchase Shares (the “**Share Repurchase Mandate**”). The Shares which may be repurchased pursuant to the Share Repurchase Mandate are up to 10% of the issued share capital of the Company on the date of passing the resolution approving the Share Repurchase Mandate.

As at 10 May 2007, the latest practicable date prior to the printing of this circular (the “**Latest Practicable Date**”), the issued share capital of the Company comprised 1,425,876,473 Shares. Assuming that there is no change in the issued share capital between the period from the Latest Practicable Date and the date of passing the resolution approving the Share Repurchase Mandate, the maximum number of Shares which may be repurchased pursuant to the Share Repurchase Mandate on the date of passing the resolution approving the Share Repurchase Mandate will be 142,587,647 Shares.

An explanatory statement as required under the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) regarding share repurchase, giving certain information regarding the Share Repurchase Mandate together with the details of the repurchases of Shares made by the Company during the six months preceding the Latest Practicable Date, are set out in Appendix I to this circular. The Share Repurchase Mandate will expire upon whichever is the earliest of: (a) the conclusion of the next annual general meeting of the Company; (b) the expiration of the period within which the next annual general meeting of the Company is required by the articles of association or by any applicable law(s); and (c) the date on which the authority given under the ordinary resolution approving the Share Repurchase Mandate is revoked or varied by an ordinary resolution of the shareholders.

3. Re-election of the Directors

Pursuant to article 112 of the articles of association of the Company, one-third of the Directors shall retire from office by rotation. Jiao Shuge, Lu Jun and Wang Huaibao will retire from office as Directors by rotation at the Annual General Meeting and being eligible, offer themselves for re-election. Particulars of Directors proposed to be re-elected at the Annual General Meeting is set out in Appendix II to this circular.

4. Annual General Meeting

A notice convening the Annual General Meeting to be held at Salon 1-3, 3/F., JW Marriott, Pacific Place, 88 Queensway, Hong Kong on Friday, 22 June 2007 at 10:00 a.m. is set out on pages 12 to 15 of this circular. At the Annual General Meeting, resolutions will be proposed to approve, inter alia, the grant of the Share Issue Mandate, the Share Repurchase Mandate and the re-election of Directors.

The procedure by which the shareholders of the Company may demand a poll at any general meeting of the Company is set out in Appendix III to this circular.

A proxy form for use at the Annual General Meeting is enclosed. Whether or not you are able to attend the Annual General Meeting, you are requested to complete the accompanying proxy form in accordance with the instructions printed thereon and return the same to the Company's Share Registrars, Computershare Hong Kong Investor Services Limited at 46th Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong as soon as possible and in any event not later than 48 hours before the time of the Annual General Meeting. Completion and delivery of the proxy form will not preclude you from attending and voting in person at the Annual General Meeting if you so wish.

5. Recommendation

The Directors believe that the grant of the Share Issue Mandate and the Share Repurchase Mandate and the re-election of Directors be proposed at the Annual General Meeting are in the best interests of the Company and the shareholders. Accordingly, the Board recommends that the shareholders to vote in favour of the resolutions in relation to the above proposals to be proposed at the Annual General Meeting.

(A) LISTING RULES

The Listing Rules permit companies with a primary listing on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) to repurchase their fully-paid up shares on the Stock Exchange subject to certain restrictions.

(B) SHAREHOLDERS’ APPROVAL

The Listing Rules provide that all on-market share repurchases by a company with its primary listing on the Stock Exchange must be approved in advance by an ordinary resolution, or alternatively by specific approval of a particular transaction or by a general mandate to the directors of the company to make such repurchases.

(C) EXERCISE OF THE SHARE REPURCHASE MANDATE

As at the Latest Practicable Date, there were 1,425,876,473 Shares in issue. Subject to the passing of the ordinary resolution approving the Share Repurchase Mandate and on the basis that no further Shares are issued or no Shares are repurchased prior to the Annual General Meeting, the Company would be allowed under the Share Repurchase Mandate to repurchase a maximum of 142,587,647 Shares, representing ten per cent (10%) of the issued share capital of the Company as at the date of passing of such resolution.

(D) REASONS FOR THE REPURCHASE OF SHARES

The Directors believe that the Share Repurchase Mandate is in the best interest of the Company and the shareholders. Repurchases may, depending on the circumstances, result in an increase in net assets and/or earnings per share. The Directors are seeking the grant of the Share Repurchase Mandate to give the Company flexibility to do so if and when appropriate. The timing and the number(s), the price and other terms upon which the same are repurchased will be decided by the Directors at the relevant time having regard to the circumstances then prevailing.

(E) SOURCE OF FUNDS

The Company is empowered by its memorandum and articles of association to purchase its Shares. In accordance with Cayman Islands law and the Company’s memorandum and articles of association, shares may only be redeemed or purchased out of the profits of the Company or out of the proceeds of a fresh issue of shares made for the purposes of the redemption or purchase. The premium, if any, payable on purchase must be provided for out of the profits of the Company or out of the Company’s share premium account before or at the time the shares are purchased or, subject to the statutory test of solvency, out of capital. Under Cayman Islands law, the Shares so repurchased will be treated as cancelled but the aggregate amount of authorised share capital will not be reduced.

It is possible that, if the Share Repurchase Mandate were to be carried out in full at any time during the proposed repurchase period, there might be a material adverse impact on the working capital or gearing position of the Company as compared with the position disclosed in the audited accounts contained in the annual report of the Company for the year ended 31 December 2006. However, the Directors do not propose to exercise the Share Repurchase Mandate to the extent that the repurchase would, in the circumstances, have a material adverse effect on the working capital position of the Company or its gearing levels which, in the opinion of the Directors, are from time to time appropriate for the Company.

(F) SHARE PRICES

(G) UNDERTAKING

The Directors have undertaken to the Stock Exchange that, so far as the same may be applicable, they will exercise the Share Repurchase Mandate in accordance with the Listing Rules and the applicable laws of the Cayman Islands.

None of the Directors nor, to the best of their knowledge having made all reasonable enquiries, any of their associates (as defined in the Listing Rules), currently intends to sell Shares to the Company or its subsidiaries in the event that the Share Repurchase Mandate is approved by the shareholders.

No connected person (as defined in the Listing Rules) has notified the Company that he has a present intention to sell the Shares to the Company, or has undertaken not to do so in the event that the Company is authorised to make repurchases of Shares.

(H) THE TAKEOVERS CODE

If, as a result of a repurchase of Shares by the Company, a shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purpose of the Takeovers Code. Accordingly, a shareholder, or group of shareholders acting in concert, could, depending on the level of increase of shareholding interest, obtain or consolidate control of the Company or become obliged to make a mandatory offer in accordance with Rules 26 and 32 of the Takeovers Code.

As at the Latest Practicable Date, Mr. Niu Gensheng ("**Mr. Niu**") holds, personally and through Yinniu Milk Industry Limited ("**Yinniu**"), a company in which he controls 81.28 per cent (81.28%) of the voting rights, 221,609,302 Shares, representing approximately 15.54 per cent (15.54%) of the total issued share capital of the Company. If the Share Repurchase Mandate is fully exercised by the Company, it will increase Mr. Niu's percentage shareholding to 17.27 per cent (17.27%).

Ten founding individuals, namely Mr. Niu, Deng Jiuqiang, Hou Jiangbin, Sun Yunbin, Qiu Lianjun, Yang Wenjun, Pang Kaitai, Lu Jun, Sun Xianhong and Xie Qiuxu, have been acting as a controlling group over the business since its inception in 1999. They as a group, are therefore the controlling shareholders of the Company. As at 31 December 2006, Mr. Niu, Deng Jiuqiang, Lu Jun, Sun Yubin, Yang Wenjun, Sun Xianhong and Qiu Lianjun who are shareholders of Jinniu Milk Industry Limited ("**Jinniu**") together control approximately 83.40 per cent (83.40%) of Jinniu, a company which holds 137,395,836 Shares, representing approximately 9.64 per cent (9.64%) of the total issued share capital of the Company as at the Latest Practicable Date. Mr. Niu, Xie Qiuxu, Pang Kaitai, Hou Jiangbin and Deng Jiuqiang who are shareholders of Yinniu together control approximately 87.20 per cent (87.20%) of Yinniu. Jinniu, Yinniu and Mr. Niu in aggregate control approximately 25.18 per cent (25.18%) and 27.98 per cent (27.98%) of the voting power at the general meeting of the Company before and after the exercise of the Share Repurchase Mandate (if exercised in full) respectively.

The Directors are not aware of any shareholder or group of shareholders acting in concert who will become obliged to make a mandatory offer as a result of a repurchase of the Shares.

(I) SHARES PURCHASED BY THE COMPANY

The Company did not repurchase any Shares in the six months prior to the Latest Practicable Date (whether on the Stock Exchange or otherwise).

Set out below are details of the Directors who will retire at the conclusion of the Annual General Meeting and will be proposed to be re-elected at the Annual General Meeting.

Mr. Jiao Shuge

Mr. Jiao Shuge (alias Jiao Zhen), aged 41, is the Chairman of the Board. Mr. Jiao joined the Group in September 2002 and is currently the general manager of CDH China Fund, L.P. Mr. Jiao received a Bachelor's degree in Mathematics from Shandong University and a Master's degree in Engineering from the Ministry of Space Industry Institute. He is currently the director of Beijing Taiyang Pharmaceuticals Industry Co., Ltd, Superdata Software Holdings Limited and China Yurun Food Group Limited.

Pursuant to the service contract entered into between the Company and Mr. Jiao on 18 May 2004, Mr. Jiao was appointed as non-executive Director for an initial term of one year and shall continue thereafter for a maximum of three years. Each party is entitled to terminate the above service contract by giving a three months' notice. Mr. Jiao is entitled to receive emoluments of approximately RMB50,000 per annum, together with an annual fixed sum bonus which is equal to one month of his average monthly salary, and a discretionary bonus. Pursuant to the service contract, his salary will be reviewed by the remuneration committee of the Company.

Mr. Jiao is not related to any Directors, senior management, substantial shareholders or controlling shareholders of the Company.

As at the Latest Practicable Date, Mr. Jiao does not have any interest in the Shares within the meaning of Part XV of the Securities and Futures Ordinance (Cap.571) ("SFO").

Ms. Lu Jun

Ms. Lu Jun, aged 51, is one of the founders of Inner Mongolia Mengniu Dairy (Group) Company Limited ("**Mengniu**"), a major operating subsidiary of the Company. Ms. Lu studied economic management at Inner Mongolia University and has extensive experience in China's dairy industry. She worked at Inner Mongolia Securities Regulatory Commission and served as the head of Inner Mongolia Property Rights Exchange. Ms. Lu is formerly a deputy chief of the Inner Mongolia Women Entrepreneurs' Association. Ms. Lu has resigned as a Vice President of the Company, and has been re-designated from an executive Director of the Company to a non-executive Director of the Company with effect from 1 January 2007.

Pursuant to the service contract entered into between the Company and Ms. Lu on 18 May 2004, Ms. Lu was appointed as executive Director for an initial term of one year and shall continue thereafter for a maximum of three years. Each party is entitled to terminate the above service contract by giving a three months' notice. Ms. Lu was re-designated as non-executive Director on 1 January 2007. The Company has not entered into any new service contract with Ms. Lu since then. Pursuant to the original service contract, she is entitled to receive emoluments of approximately RMB30,000 per annum, together with an annual fixed sum bonus which is equal to one month of her average monthly salary, and a discretionary bonus. Pursuant to the service contract, her salary will be reviewed by the remuneration committee of the Company.

Ms. Lu is not related to any Directors, senior management, substantial shareholders or controlling shareholders of the Company.

As at the Latest Practicable Date, Ms. Lu does not have any interest in the Shares within the meaning of Part XV of the SFO.

Ms. Lu is interested in the shares of Mengniu. As at the Latest Practicable Date, she holds 804,646 shares in Mengniu, representing approximately 0.30% of the total issued share capital of Mengniu.

Mr. Wang Huaibao

Mr. Wang Huaibao, aged 69, currently serves as deputy chairman of the Dairy Association of China. Mr. Wang graduated from China People's University. Mr. Wang served as the chairman and a general manager for Beijing Milk Company (now Beijing Sanyuan Food Company Limited). He also served as the chairman of the China Dairy Industry Association. He was appointed as an independent director of Mengniu on 18 October 2002 and became an independent director of the Company on 23 February 2004.

Pursuant to the letter of appointment entered into between the Company and Mr. Wang on 18 May 2004, Mr. Wang was appointed as an independent non-executive Director for an initial term of one year and shall continue thereafter for a maximum of three years. He is entitled to receive emoluments of approximately RMB50,000 per annum.

Mr. Wang is not related to any Directors, senior management, substantial shareholders or controlling shareholders of the Company.

As at the Latest Practicable Date, Mr. Wang does not have any interest in the Shares within the meaning of Part XV of the SFO.

Each of Mr. Jiao, Ms. Lu and Mr. Wang has confirmed that there are no other matters that need to be brought to the attention of the Shareholders with their re-election and that no information needs to be disclosed under paragraphs (h) to (v) of Rule 13.51(2) of the Listing Rules.

Article 76 of the articles of association of the Company sets out the procedure by which shareholders may demand a poll:

At any general meeting a resolution put to the vote of the meeting shall be decided on a show of hands unless a poll is (before or on the declaration of the result of the show of hands or on the withdrawal of any other demand for a poll) demanded:

- (i) by the Chairman of the meeting; or
- (ii) by at least five members present in person (or, in the case of a member being a corporation, by its duly authorised representative) or by proxy for the time being entitled to vote at the meeting; or
- (iii) by any member or members present in person (or, in the case of a member being a corporation, by its duly authorised representative) or by proxy and representing not less than one-tenth of the total voting rights of all the members having the right to vote at the meeting; or
- (iv) by any member or members present in person (or, in the case of a member being a corporation, by its duly authorised representative) or by proxy and holding Shares conferring a right to vote at the meeting being shares on which an aggregate sum has been paid up equal to not less than one-tenth of the total sum paid up on all the shares conferring that right.

Unless a poll be so demanded and not withdrawn, a declaration by the Chairman that a resolution has on a show of hands been carried or carried unanimously, or by a particular majority, or lost, and an entry to that effect in the book containing the minutes of the proceedings of the Company shall be conclusive evidence of the fact without proof of the number or proportion of the votes recorded in favour or against such resolution.

- (iii) the revocation or variation of the authority given to the Directors under this Resolution 6 by the passing of an ordinary resolution by the shareholders in general meeting.
