ANNUAL GENERAL MEETING HELD ON 3 JUNE 2016 – POLL RESULTS

At the Annual General Meeting (the “AGM”) of China Mengniu Dairy Company Limited (the “Company”) held on 3 June 2016, all the resolutions as set out in the Notice of Annual General Meeting dated 30 April 2016 (the “Notice of AGM”) were voted on by poll. The Company’s share registrar in Hong Kong, Computershare Hong Kong Investor Services Limited, acted as scrutineer for the vote-taking at the AGM.

As at the date of the AGM, the number of issued share capital of the Company was 3,919,266,402 shares, which was the total number of shares entitling the holders to attend and vote for or against all the resolutions at the AGM. There were no restrictions on any shareholders casting votes on any of the resolutions at the AGM.

The Final Dividend to be paid to the Company’s shareholders shall be HK\$0.165 per ordinary share, calculated with reference to the median exchange rate between Renminbi (“**RMB**”) and Hong Kong Dollars (“**HK\$**”) as announced by the People’s Bank of China on 3 June 2016 (the date when the shareholders of the Company approved the Final Dividend) which was HK\$1=RMB0.84678.
