UNAUDITED THIRD QUARTER RESULTS OF 2014

ANNOUNCEMENT PURSUANT TO THE INSIDE INFORMATION PROVISIONS AND RULE 13.09(2) OF THE LISTING RULES

This announcement is made by China State Construction International Holdings Limited (the “Company”) pursuant to the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong) and Rule 13.09(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”).

The Company is an indirect subsidiary of China State Construction Engineering Corporation Limited (“CSCECL”, whose shares are listed on The Shanghai Stock Exchange). As at the date of this announcement, CSCECL beneficially owns 57.00% of the existing issued share capital of the Company. CSCECL will release its unaudited quarterly results for the nine months ended 30 September 2014 pursuant to the listing rules of The Shanghai Stock Exchange before the end of October 2014. Such results will contain certain financial information of the Company and its subsidiaries (collectively, the “Group”).

To ensure that shareholders of the Company and potential investors have equal and timely access to the information of the Company, the Company hereby releases the unaudited results of the Group for the nine months ended 30 September 2014.

The unaudited revenue of the Group for the nine months ended 30 September 2014 was approximately HK\$22,515,865,000 (30 September 2013 (restated): HK\$17,600,402,000). While the aggregate amounts of operating profit and the share of profits of joint ventures were approximately HK\$2,847,499,000 (30 September 2013: (restated) HK\$2,253,292,000). The results and the comparatives are prepared on the same basis as for the preparation of the audited consolidated financial statement for the year ended 31 December 2013.

The Company's shareholders and potential investors should note that **all the figures contained herein are unaudited. Accordingly, figures contained in this announcement should in no way be regarded as to provide any indication or assurance on the financial results of the Group for the nine months ended 30 September 2014.**
