**OPERATING INFORMATION FOR THE TEN MONTHS
ENDED 31 OCTOBER 2017**

The Group recorded an accumulated new contract value of HK\$90.12 billion in the ten months ended 31 October 2017, and hence achieved a 90.1% completion of the full year target of 2017 (which has been revised up to no less than HK\$100.0 billion).

As of 31 October 2017, the on-hand contract value of the Group amounted to approximately HK\$328.08 billion, among which the backlog was approximately HK\$194.22 billion.

Major New Contracts Awarded in October 2017 include:

The Highway PPP Project, Anhui Province (The attributable contract value of the Group is about HK\$7.47 billion. Such project includes total length of 221.4 kilometers of the highway. The construction period is about 48 months.);

The Airport Highway PPP Project, Shiyan, Hubei Province (The attributable contract value of the Group is about HK\$0.95 billion. Such project includes total length of 10.9 kilometers of the first class road. The construction period is about 24 months.).
