ANNOUNCEMENT PURSUANT TO RULE 13.18 OF THE LISTING RULES

This announcement is made by Logan Property Holdings Company Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.18 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”).

On 8 April 2020, the Company as borrower entered into a facility agreement (the “**Facility Agreement**”) with certain banks as lenders pursuant to which a dual-currency USD and HKD term loan facilities of HK\$2,230,000,000 equivalent (with green shoe option of up to HK\$770,000,000) with a term of 36 months has been granted to the Company (the “**Facilities**”).

As provided in the Facility Agreement, if (i) Ms. Kei Perenna Hoi Ting and her family collectively ceases to own, directly or indirectly, more than 50 per cent. of the Company’s total issued share capital, free from any security; and/or (ii) Mr. Kei Hoi Pang and his family ceases to maintain control of the Group’s business, if the majority lenders under the Facilities so require, the Company shall prepay the Facilities in full within the time specified under the Facility Agreement.

The Company will continue to make relevant disclosure in its subsequent interim and annual reports of the Company pursuant to Rule 13.21 of the Listing Rules for as long as circumstances giving rise to the obligation under Rule 13.18 of the Listing Rules continue to exist.
