The board of directors (the “**Board**”) of Logan Property Holdings Company Limited (the “**Company**”, together with its subsidiaries, associates and joint ventures, the “**Group**”) hereby announces that the contract sales of the Group was approximately RMB10.86 billion in June 2019, representing a year-on-year increase of 63.5%. The gross floor area of contract sales was approximately 849,000 sq.m., and the unit price of contract sales was approximately RMB12,687. For the six months ended 30 June 2019, the contract sales was approximately RMB45.31 billion, representing a year-on-year increase of 27.7%, and the gross floor area of contract sales was approximately 3,392,000 sq.m.
