## **GRANT OF SHARE OPTIONS**

This announcement is made by China Dongxiang (Group) Co., Ltd. (the “**Company**”) pursuant to Rule 17.06A of the Rules Governing the Listing of Securities (the “**Listing Rules**”) on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”).

The board of directors (the “**Board**”) of the Company hereby announces that on 15 April 2021 (the “**Grant Date**”), the Company granted an aggregate of 189,400,000 share options (the “**Options**”) to certain employees and three executive directors of the Company (the “**Directors**”) (collectively, the “**Grantees**”), subject to acceptance of the Grantees, to subscribe for a total of 189,400,000 ordinary shares of HK\$0.01 each in the share capital of the Company (the “**Share(s)**”) pursuant to the share option scheme adopted by the Company on 8 August 2019.

Each Option shall entitle the holder of such Option to subscribe for one Share upon exercise of such Option at an exercise price of HK\$0.94 per Share, which is the highest of: (a) the closing price of HK\$0.94 per Share as stated in the Stock Exchange’s daily quotation sheets on the Grant Date; (b) the average closing price of HK\$0.932 per Share as stated in the Stock Exchange’s daily quotation sheets for the five business days immediately preceding the Grant Date; and (c) the nominal value of HK\$0.01 per Share.

Options granted are valid for a period from the Grant Date to 14 April 2031. Among the Options granted as stated above, a total of 65,000,000 Options were granted to the Directors, details of which are as follows:
