## **OPERATIONAL DATA FOR THE THIRD QUARTER AND THE FIRST NINE MONTHS OF FY2021/22**

This announcement is made on a voluntary basis by the board of directors (the “**Board**”) of China Dongxiang (Group) Co., Ltd. (the “**Company**”, together with its subsidiaries, the “**Group**”) for providing operational data of the Group for the third quarter comprising the three months ended 31 December 2021 (“**FY2021/22 Q3**”) and the nine months ended 31 December 2021 (the “**Nine Months of FY2021/22**”).

### **RETAIL PERFORMANCE**

For the FY2021/22 Q3, the retail performance of Kappa stores of the Group (including Kappa kids’ apparel business) for the overall platform registered a mid-teen decline on a year-on-year basis.

The retail performance of the overall platform for the Nine Months of FY2021/22 (including Kappa kids’ apparel business) recorded a mid-to-high single-digit decline on a year-on-year basis.

### **SAME-STORE-SALES (SSS)**

For the FY2021/22 Q3, in respect of Kappa stores (including Kappa kids’ apparel business) which have been in operation since the beginning of the same quarter last year, the SSS for the overall platform registered a mid-to-high-teen decline.

The SSS for the overall platform for the Nine Months of FY2021/22 recorded a mid-to-low-teen decline on a year-on-year basis.

## NUMBER OF RETAIL STORES

For the third quarter ended 31 December 2021, the number of Kappa-branded stores of the Group was 1,419 (including Kappa kids' apparel business), which was a net increase of 44 as compared to those as at 31 March 2021 (“end of FY2020/21”).
