Pursuant to the extraordinary general meeting of the Company held on 4 November 2020, a resolution was passed by shareholders of the Company to grant a specific mandate to the directors to allot and issue at par cumulative perpetual non-voting and non-convertible offshore preference shares of HKD100 par value each for the aggregate subscription price of HK\$1,631,620,000 (the “**EGM Resolution**”). On 22 December 2020, the Company issued 11,000,000 preference shares of HKD100 each and on 31 December 2020, the Company issued 4,705,200 preference shares of HKD100 each, pursuant to the EGM Resolution.
