Remarks (if any):

Pursuant to the extraordinary general meeting of the Company held on 4 November 2020, a resolution was passed by shareholders of the Company (the “**Shareholder**”) to grant a specific mandate to the directors to allot and issue at par cumulative perpetual non-voting and non-convertible offshore preference shares of HKD100 par value each for the aggregate subscription price of HK\$1,631,620,000 (the “**EGM Resolution**”). On 22 December 2020, the Company issued 11,000,000 preference shares of HKD100 each and on 31 December 2020, the Company issued 4,705,200 preference shares of HKD100 each, pursuant to the EGM Resolution.

Pursuant to an extraordinary general meeting of the Company held on 7 May 2021, an ordinary resolution was passed by Shareholders to increase the authorised share capital of the Company from HK\$3,000,000,000 to HK\$5,000,000,000 comprised of 33,683,800,000 ordinary shares of HKD0.1 par value each and 16,316,200 preference shares of HKD100 par value each, and to confirm the re-classification of the authorised share capital of the Company by the creation of 16,316,200 preference shares of HKD100 par value each having the same rights and privileges as approved by the Shareholders pursuant to the EGM Resolution. On 14 May 2021, the Company issued 611,000 preference shares of HKD100 each, bringing the total number of preference shares in issue to an aggregate of 16,316,200 preference shares of HKD100 each.
