VOLUNTARY ANNOUNCEMENT — INCREASE IN SHAREHOLDING BY A CONTROLLING SHAREHOLDER

The board (the “**Board**”) of directors (the “**Directors**”) of the Company hereby announces that, as informed by Ms. Li Suwen (“**Ms. Li**”), the chairperson, an executive Director and a controlling shareholder of the Company, Ms. Li acquired an aggregate of 300,000 ordinary shares (the “**Shares**”) of the Company on the market on 4 September 2020 at an average purchase price of approximately HK\$2.99 per Share.

Following the above acquisition of Shares by Ms. Li, her shareholding interest in the Company has increased to approximately 26.29% of the total issued share capital of the Company as at the date of this announcement. Ms. Li and Mr. Liu Xuebin, another controlling shareholder of the Company acting in concert with Ms. Li, are in aggregate interested in 1,505,328,000 Shares, representing approximately 69.14% of the total issued share capital of the Company as at the date of this announcement.
