CHARACTERISTICS OF GEM

INTRODUCTION

The purpose of this circular is to give you notice of the AGM and information regarding resolutions to be proposed at the AGM relating to (i) the granting to the Directors of general mandates to issue new Shares and repurchase Shares; and (ii) the re-election of Directors.

PROPOSED GENERAL MANDATE TO ISSUE NEW SHARES

At the AGM, an ordinary resolution set out in resolution No. 4(A) of the notice of the AGM will be proposed whereby if passed, the Directors will be given a general and unconditional mandate to allot, issue or otherwise deal with additional Shares not exceeding the sum of 20% of the aggregate nominal amount of the issued share capital of

the Company at the date of passing of the resolution and the nominal amount of any Shares repurchased by the Company up to a maximum of 10% of the issued share capital of the Company at the date of passing of the resolution.

The authority conferred by the above resolution will commence at the date of passing of the relevant resolution until whichever is the earliest of:

- (i) the conclusion of the next annual general meeting of the Company following the passing of the relevant resolution at which time the authority shall lapse unless, by ordinary resolution passed at that meeting, the authority is renewed, either unconditionally or subject to conditions;
- (ii) the expiration of the period within which the next annual general meeting of the Company is required by the articles of association of the Company or any applicable laws of the Cayman Islands to be held; and
- (iii) the revocation, variation or renewal of this resolution by an ordinary resolution of the shareholders of the Company in general meeting.

PROPOSED GENERAL MANDATE TO REPURCHASE SHARES

At the AGM, it is proposed to seek your approval of the ordinary resolution No. 4(B) as set out in the notice of the AGM to give a fresh mandate to the Directors to exercise the power of the Company to repurchase Shares up to a maximum of 10% of the issued share capital of the Company at the date of passing of the resolution (“Repurchase Mandate”).

The authority conferred by the Repurchase Mandate will commence at the date of passing of the relevant resolution until whichever is the earliest of:

- (i) the conclusion of the next annual general meeting of the Company following the passing of the relevant resolution at which time the authority shall lapse unless, by ordinary resolution passed at that meeting, the authority is renewed, either unconditionally or subject to conditions;
- (ii) the expiration of the period within which the next annual general meeting of the Company is required by the articles of association of the Company or any applicable laws of the Cayman Islands to be held; and
- (iii) the revocation, variation or renewal of this resolution by an ordinary resolution of the shareholders of the Company in general meeting.”

An explanatory statement, as required by the relevant rules as set out in GEM Listing Rules to regulate the repurchase by companies with primary listings on the Stock Exchange of their own securities on the Stock Exchange, to provide requisite information to you for your consideration of the Repurchase Mandate, is set out in Appendix I to this circular.

PROPOSED RE-ELECTION OF DIRECTORS

In accordance with Article 86(3) of the articles of association of the Company, Mr. Andrew James Chandler (“Mr. Chandler”), who was appointed as a Director after the last annual general meeting of the Company, will hold office until the AGM, and will offer himself for re-election at the AGM. In addition, in accordance with Article 87 of the articles of association of the Company, Mr. Yang Qiulin (“Mr. Yang”), and Mr. Zhang Daorong (“Mr. Zhang”) shall retire from office by rotation at the AGM. The retiring Directors, being eligible, will offer themselves for re-election at the AGM.

Details of Mr. Chandler, Mr. Yang, and Mr. Zhang which are required to be disclosed under GEM Listing Rules are set out in Appendix II of this circular.

AGM

A notice convening the AGM is set out on pages 10 to 13 of this circular.

A form of proxy for the AGM is enclosed herewith. Whether or not you are able to attend the AGM in person, please complete and return the enclosed proxy form in accordance with the instructions printed thereon to the branch share registrar of the Company, Hong Kong Registrars Limited, at 46th Floor, Hopewell Centre, 183 Queen’s Road East, Hong Kong, as soon as possible and in any event not less than 48 hours before the time appointed for holding the AGM or any adjourned meeting. Completion and return of the proxy forms will not preclude you from attending and voting in person at the AGM or any adjourned meeting should you so wish.

RECOMMENDATION

The Directors consider that the above proposals relating to the general mandate to issue new Shares, the Repurchase Mandate and the re-election of Directors are in the best interests of the Company and its Shareholders. Accordingly, the Directors recommend you to vote in favour of such resolutions at the AGM.

This appendix serves as an explanatory statement, as required by GEM Listing Rules, to provide the requisite information to you for your consideration of the Repurchase Mandate.

SHARE CAPITAL

As at the Latest Practicable Date, the issued share capital of the Company comprised 963,417,986 Shares.

Subject to the passing of the relevant ordinary resolution to approve the Repurchase Mandate and on the basis that no further Shares will be issued or repurchased prior to the AGM, the Company would be allowed under the Repurchase Mandate to repurchase Shares up to a maximum of 96,341,798 Shares.

REASONS FOR REPURCHASES

The Directors believe that the proposed granting of the Repurchase Mandate is in the interests of the Company and its shareholders. Such purchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net assets and/or earnings per Share and will only be made when the Directors believe that such a purchase will benefit the Company and its shareholders. At present, the Directors have no intention to repurchase any of the Shares.

FUNDING OF REPURCHASES

In repurchasing Shares, the Company may only apply funds legally available for such purpose in accordance with the memorandum and articles of association of the Company and the applicable laws of Hong Kong and the Cayman Islands.

It is presently proposed that any purchase of the Shares would be made out of profits of the Company or the proceeds of a fresh issue made for the purpose or out of capital provided that on the day immediately following the date of repurchase the Company is able to pay its debts as they fall due in the ordinary course of business.

There might be a material adverse impact on the working capital or gearing position of the Company disclosed in the Company's latest audited financial statements in the Annual Report in the event that the proposed repurchase of shares was to be carried out in full at any time during the proposed repurchase period. However, the Directors expect to exercise such mandate if and to such extent only as they are satisfied that the exercise thereof will not have such a material adverse impact.

UNDERTAKING

The Directors have undertaken to the Stock Exchange that, so far as the same may be applicable, they will exercise the Repurchase Mandate in accordance with GEM Listing Rules and the applicable laws and regulations of the Cayman Islands.

None of the Directors, nor, to the best of their knowledge having made all reasonable enquiries, any of their associates, have any present intention to sell any Shares to the Company under the Repurchase Mandate if such is approved by the Shareholders.

No other connected persons (as defined in GEM Listing Rules) have notified the Company that they have a present intention to sell Shares to the Company, or have undertaken not to do so, in the event that the Repurchase Mandate is approved by the Shareholders.

HONG KONG CODE ON TAKEOVERS AND MERGERS

If as a result of a repurchase of Shares, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purpose of the Hong Kong Code on Takeovers and Mergers ("Takeovers Code"). As a result, a Shareholder or a group or Shareholders acting in concert, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in

accordance with Rules 26 and 32 of the Takeovers Code. The Directors are not aware of any consequences under the Takeovers Code as a result of the exercise of the Repurchase Mandate.

If the Repurchase Mandate were exercised in full, the percentage shareholding of the substantial shareholders of the Company before and after such repurchase would be as follows:

Notes:

- (1) Asian Dynamics International Limited is a company incorporated in the British Virgin Islands and beneficially owned by Asian Wealth Incorporated, Denwell Enterprises Limited, Glamour House Limited, Mr. Chan Chi Ming and Mr. Chau Tak Tin.

The Directors will not exercise the Repurchase Mandate (whether in whole or in part) to the extent which would result in the number of Shares being held by the public falling below the relevant minimum prescribed percentage of the Company as required by the Stock Exchange, which is currently 25% of the entire issued share capital of the Company.

SHARE REPURCHASE MADE BY THE COMPANY

The Company has not purchased any of its Shares (whether on the Stock Exchange or otherwise) in the six months preceding the date of this circular.

The following are the details of the Directors proposed for re-election at the AGM:-

Mr. Andrew James Chandler

Mr. Chandler, aged 37, joined the Company in August 2006, and was previously responsible for the legal and corporate compliance related matters of the Company. Mr. Chandler was admitted as a barrister of the High Court of Hong Kong in 1998, and as a barrister and solicitor of the High Court of New Zealand in 1996. Mr. Chandler has over 11 years of experience in the legal field. Mr. Chandler graduated from Victoria University in Wellington, New Zealand with a Bachelor of Laws, and Bachelor of Arts degrees. Mr. Chandler has also obtained a Post Graduate Certificate in Laws from City University, Hong Kong, and a Graduate Diploma in Business Studies, majoring in Finance, from Massey University, New Zealand.

Mr. Chandler does not hold other directorships in listed public companies in the last 3 years. He has no interest in the Shares of the Company within the meaning of Part XV of the Securities and Futures Ordinance.

The Company has entered into a service contract with Mr. Chandler, for an undefined term, whereby Mr. Chandler is entitled to a monthly emolument of HK\$45,000, and which is subject to review on a half-yearly basis. Mr. Chandler is subject to retirement and re-election at the AGM in accordance with the provisions of the articles of association of the Company.

Total emoluments of HK\$128,000 were paid to Mr. Chandler for the year ended 31 December 2009 while Mr. Chandler was a Director of the Company.

Prior to his appointment as a Director Mr. Chandler was the company secretary, authorised representative and legal counsel of the Company, and its various subsidiaries. Mr. Chandler does not have any relationships with other director, senior management, management shareholder, substantial shareholder or controlling shareholder of the Company as defined in the GEM Listing Rules. There is no additional information required to be disclosed pursuant to Rules 17.50(2)(h)-(v) of the GEM Listing Rules.

There are no other matters that need to be brought to the attention of the Shareholders in relation to the proposed re-election of Mr. Chandler as a Director.

Mr. Yang Qiulin

Mr. Yang, aged 37, joined the Group in December 2006. He graduated from Xiang Tan University, the People's Republic of China with a Business Management degree. He is a practicing lawyer as well as a certified public accountant of China. Mr. Yang is now a senior partner of a law firm in Guangzhou, specializing in commercial and corporate law. Mr. Yang has over 11 years experience in the legal field.

Mr. Yang does not hold other directorships in listed public companies in the last 3 years. He has no interest in the Shares of the Company within the meaning of Part XV of the Securities and Futures Ordinance.

There is no service contract entered into with Mr. Yang, who is subject to retirement and re-election at the AGM in accordance with the provision of the Articles of Association of the Company.

No director fee was paid to Mr. Yang for the year ended 31 December 2009. The director's fee payable to Mr. Yang will be determined by the remuneration committee with reference to his contribution in terms of time, effort and his expertise and will be subject to review on an annual basis.

Mr. Yang does not have any relationships with other director, senior management, management shareholder, substantial shareholder or controlling shareholder of the Company as defined in the GEM Listing Rules. There is no additional information required to be disclosed pursuant to Rules 17.50(2)(h)-(v) of the GEM Listing Rules.

There are no other matters that need to be brought to the attention of the Shareholders in relation to the proposed re-election of Mr. Yang as a Director.

Mr. Zhang Daorong

Mr. Zhang, aged 38, is a Certified Public Accountant and Certified Tax Agent in the PRC. He holds a Bachelor degree in Economics and a Master degree in Business Administration. He has over 16 years of experience in accounting, auditing and taxation. He is currently a project manager in a firm of certified public accountants in the PRC.

Mr. Zhang does not hold other directorships in listed public companies in the last 3 years. Mr. Zhang has no interest in the Shares of the Company within the meaning of Part XV of the Securities and Futures Ordinance.

There is no service contract entered into with Mr. Zhang, who is subject to retirement and re-election at the AGM in accordance with the provision of the Articles of Association of the Company.

A director fee in the amount of HK\$48,000 was paid to Mr. Zhang for the year ended 31 December 2009. Mr. Zhang will be entitled to a director fee for the year ended 31 December 2010 to be determined by the remuneration committee with reference to his contribution in terms of time, effort and his expertise and will be subject to review on an annual basis.

Mr. Zhang does not have any relationships with other director, senior management, management shareholder, substantial shareholder or controlling shareholder of the Company as defined in the GEM Listing Rules. There is no additional information required to be disclosed pursuant to Rules 17.50(2)(h)-(v) of the GEM Listing Rules.

There are no other matters that need to be brought to the attention of the Shareholders in relation to the proposed re-election of Mr. Zhang as a Director.

3. To re-appoint auditors and to authorize the Board of Directors to fix their remuneration;

- (C) “**THAT** conditional upon the passing of Resolution No. 4(B), the general mandate granted to the Directors of the Company and for the time being in force to exercise the powers of the Company to allot, issue and deal with shares of the Company pursuant to Resolution No. 4(A) be and is hereby extended by the addition to the aggregate nominal amount of the share capital of the Company which may be allotted or agreed conditionally or unconditionally to be allotted by the Directors pursuant to such general mandate an amount representing the aggregate nominal amount of the share capital of the Company repurchased by the Company under the authority granted pursuant to Resolution No. 4(B), provided that such amount shall not exceed 10% of the aggregate nominal amount of the issued share capital of the Company at the date of passing this Resolution.”
