The board of directors of the Company has been informed by Powerleader Network that the application for initial public offering and listing of the shares of Powerleader Network on the Growth Enterprise Market of the Shenzhen Stock Exchange has been approved by the CSRC GEM Committee on 25 December 2009 and the approval documents were officially issued by the CSRC GEM Committee on 20 January 2010.

It shall be noted that the particulars of the initial public offering and listing date for the shares of Powerleader Network are yet to be confirmed and finalized. Therefore, shareholders of the Company and potential investors are advised to exercise caution when dealing in the shares of the Company.

This announcement is made pursuant to Rule 13.09(1) of the Rules Governing the Listing of Securities on the Growth Enterprise Market of the Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”).

The board of directors of Powerleader Science & Technology Group Limited (the “**Company**”) has been informed by its associate, 深圳市中青寶網網絡科技股份有限公司 (“**Powerleader Network**”), that the application for initial public offering and listing of the shares of Powerleader Network on the Growth Enterprise Market of the Shenzhen Stock Exchange has been approved by the Growth Enterprise Market of Public Offering Review Committee of the China Securities Regulatory Commission (中國證券監督管理委員會創業板發行審核委員會) (the “**CSRC GEM Committee**”) on 25 December 2009 and the approval documents were officially issued by the CSRC GEM Committee on 20 January 2010.

It is expected that Powerleader Network will issue not more than 25,000,000 shares of RMB1.00 each in nominal value by way of initial public offering, and will seek to be listed on the Growth Enterprise Market of the Shenzhen Stock Exchange (the “**Listing Proposal**”). Should the initial public offering and listing go ahead in accordance with the above-mentioned Listing Proposal, the Company’s shareholding in Powerleader Network following completion of the initial public offering and listing may become not higher than 15.3%. As at the date hereof, the Company is holding approximately 20.4% equity interest in Powerleader Network.

It shall be noted that the particulars of the initial public offering and listing date for the shares of Powerleader Network are yet to be confirmed and finalized. Therefore, shareholders of the Company and potential investors are advised to exercise caution when dealing in the shares of the Company.
