**POSSIBLE DELAY IN PUBLICATION OF ANNUAL RESULTS  
AND DESPATCH OF THE ANNUAL REPORT

POSTPONEMENT OF BOARD MEETING**

Powerleader Science & Technology Group Limited (the “**Company**”) announces that the publication of the announcement of the annual results of the Company and its subsidiaries (the “**Group**”) for the year ended 31 December 2014 (the “**Annual Results**”) and the despatch of the annual report of the Company for the year ended 31 December 2014 (the “**Annual Report**”) are expected to be delayed, as additional time is required to finalise the Annual Results. This is due to the postponement of the publication of the 2014 annual report of 深圳中青宝互動網絡股份有限公司 (Shenzhen ZQ Game Co., Ltd.), an associated company of the Group, caused by its audit work not being able to be completed on time.

The meeting of the board of directors of the Company to, among other things, consider and approve the Annual Results and the Annual Report originally scheduled to be held on 27 March 2015 will be postponed. The Company expects that the Annual Results and the Annual Report will be completed by 28 April 2015. The Company will publish further announcement(s) regarding the Annual Results and the Annual Report as and when appropriate.

The possible failure by the Company to publish the Annual Results and to despatch the Annual Report within 3 months after the date of the financial year end, i.e. by 31 March 2015 will constitute non-compliance with Rules 18.03 and 18.49 of the Rules Governing the Listing of Securities on the Growth Enterprise Market of The Stock Exchange of Hong Kong Limited. If the Company is not able to publish the Annual Results by 31 March 2015, the Company will request for a suspension of trading of its H shares on the Growth Enterprise Market of The Stock Exchange of Hong Kong Limited pending the publication of the Annual Results.
